I hereby authorize Kingman Yacht Center, Inc. to implement the above plan or alternate plan. I understand and agree that the Marina is not liable for loss, damage, third party damage or loss to property or person in the event of acts of God, storms, floods, or high winds. I agree to evacuate the property of the Marina together with my boat when a hurricane mobilization is declared by the Marina since no such facility can guarantee/warranty safety in abnormal weather conditions. It is my responsibility to remove my boat in a timely manner or instruct the Marina to secure it at my expense if the Marina is able to do so, without liability to the Marina. I understand that I bear total responsibility for damage to and caused by my boat under these circumstances. If I do not remove my boat from the marina property, I agree that the Marina may do whatever it deems necessary to provide safe harbor for the vessel and protect the marina facility, at full cost to me, but with no responsibility on its part or on the part of the Marina's insurance underwriter, and that such refusal will immediately void my Dockage Contract. I further understand that mobilization charges will be assessed to me if Kingman Yacht Center determines that implementation of this plan is necessary and I have not removed my boat from the facility. The amount of these charges will be based upon the total mobilization expense incurred by the Marina, prorated by boat length. I agree to pay for any and all charges assessed.
